I acknowledge that I understand the nature of the activities that my child will be participating in and the possibility that despite precautions, accidents or physical injury to my child may occur.

I agree to release and hold Integrity School of Dance, Inc. harmless, including its shareholders, officers, directors, instructors, and staff members, and any other agents from any cause of action, claims, or demands now and in the future whether known, unknown, anticipated or unanticipated. I will not hold Integrity School of Dance, Inc. liable for any personal injury or any personal property damage or loss which may occur on the premises or while using the facility's equipment before, during or after classes, or which may occur at any Integrity School of Dance, Inc. sponsored event outside the studio, including during the course of transportation to or from any event taking place outside the studio. I am aware of the possible risks inherent in the nature of the activities provided by Integrity School of Dance, Inc., and that the school does not provide medical insurance covering injuries of any nature which may occur during any activity or event.

Furthermore I/we agree to read and follow the class and facility policies and take full responsibility for my/our behavior in addition to any damage I/we may cause to the facilities utilized by Integrity School of Dance, Inc. I/we agree to give Integrity School of Dance authority to discontinue enrollment upon their discretion. A copy of the dance studios policies is available upon request.

I authorize and agree that Integrity School of Dance, Inc. may take and use photographs, videos or likenesses of myself or my child as needed for its record-keeping, advertising, social media, public relations or educational projects, and that I have no rights to the same and will not be compensated for the same. I further release Integrity School of Dance, Inc., and its successor and assigns, from all liability associated with the use of such photographs, videos or likenesses.

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19
The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people. Integrity School of Dance, Inc. (ISO Dance) has put in place preventative measures to reduce the spread of COVID-19; however, ISO Dance cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending ISO Dance could increase your risk and your child(ren)'s risk of contracting COVID-19.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at ISO Dance or participation in Dance programming ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless ISO Dance, its employees, independent contractors, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of ISO Dance, its employees, independent contractors, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Dance program.

My signature is proof of my intention to execute a complete and unconditional waiver and release of all liability pursuant to the terms herein, and my agreement as to all terms and conditions contained above. I am authorized to sign on behalf of the minor, and I am of lawful age and competent to sign this affirmation.
